



# Rack & Spur Hunt Club, LLC

## 2026 Rules, Regulations, Policies & Safety Standards

Effective January 1<sup>st</sup>, 2026

1. **Safety:** Safety is key to enjoying the outdoors and our #1 priority. Rack & Spur Hunt Club, LLC, follows all laws and regulations declared by South Carolina Law and enforced by the South Carolina Department of Natural Resources and other South Carolina Law Enforcement agencies. All laws and regulations related to hunting and other activities must be followed. In addition to the laws of the state of South Carolina, Rack & Spur Hunt Club, LLC has additional rules, regulations, policies and safety standards in place that must be adhered to at all times. Failure to follow these can result in fines and/or dismissal from the club. These safety standards can be changed at any time by the club leadership for the purpose of enhanced safety for our members and visitors while on club property. Additional club safety standards are:
  - a. **Communications.** Always have a means to communicate with someone (e.g. a cell phone).
  - b. **Minors.** No one under the age of 18 can hunt on the property without a parent or guardian who is a Rack & Spur Hunt Club, LLC member AND present with that person in the same stand. This is as per our lease agreements.
  - c. **Blaze Orange.** During deer Primitive Weapon and Rifle Season, everyone must wear blaze orange (hunters orange) at any time they are entering or exiting a hunting area, entering or exiting a stand, or are on the ground.
  - d. **Flashlight.** Everyone must use a flashlight during the hours of darkness when entering or exiting the property or on the ground during the hours of darkness for any reason.
  - e. **Never** leave a hunting area at night unless you know everyone in that hunting area is accounted for. Don't leave a fellow member in the woods unaccounted for.
  - f. **All members and visitors** must sign a release of liability form prior to participating in any activity on Rack & Spur Hunt Club, LLC property.
  - g. **Profanity.** Rack & Spur Hunt Club, LLC promotes an atmosphere of respect and family. Please refrain from using excessive profanity. If possible, please refrain from the use of any profanity.

2. **Draw days, Signing in/out & Entering & Exiting hunting areas.**

- a. There will be a draw at the clubhouse every opening day of Turkey Season, Deer Bow Season, Deer Primitive Weapon Season, and Deer Rifle Season, and every Saturday of that particular season. The only exception to this is for late deer season. After Thanksgiving, there will not be a draw at the club house and all hunters may go directly to the tracts.
- b. The draw is held at 5:30 AM at the clubhouse. Those that wish to hunt their club or IP stands may hunt these without participating in the draw, however you must be at the draw where you will be given the opportunity to claim your stand prior to those that are participating in the draw. **Stands CANNOT be signed in for prior to 5:30 AM on the day of the hunt.**
- c. Make certain you sign in and out appropriately for ALL scouting and hunting activities and that you sign in and out with your COMPLETE name and the other information required on the sign in/out sheets as in this example:

- d. **On Saturday draw days only**, ALL stands are signed in and out for at the clubhouse for all hunts **NO EXCEPTIONS!**
- e. **On Saturday draw days only**, you can sign in at the clubhouse for a hunt and place the letters “NCB” (Not Coming Back) in the comments section. This eliminates the need for you to travel back to the clubhouse to sign back out.
- f. On days other than draw days and any day after Thanksgiving (for deer season), members can go directly to the tract of land to sign in and out keeping in mind that **everyone must sign in and out. You CANNOT sign in for a stand prior to 5:30 AM the day of the hunt. You cannot use NCB at the individual tracts of land. You must put the TIME IN and TIME OUT in the sign in/out book.**



- g. **TURKEY SEASON ONLY.** The tracts are separated into sections, usually denoted on the map in the map room and at the sign in/out board at the tract. On opening day and every Saturday, the hunter will sign in for a section and tag out on the map in the map room at the club house and ALSO at the sign in/out board at the tract. If the bird goes beyond the boundaries of the section the hunter is signed in for and they would like to stalk the bird, the hunter must go back to the sign in/out board at the tract and sign out from the section they were on and sign in for the section they want to move to, permitted there is no one else already hunting that section.
- h. **Entering and Exiting Hunting Areas.** Always take the most direct route in & out of the property. For morning hunts, if daylight has broken, do not go past anyone that has already taken a stand until after **10:00 AM** and for evening hunts, do not go past anyone within **2 hours** of dark until after legal shooting time. You should stay in your stand until at least 10:00 AM and until after legal shooting time in the evenings unless you have a medical emergency or need to retrieve a harvest.
3. **Vehicle Travel on the Properties.**
- Vehicle travel will be restricted on all tracts after Labor Day weekend** unless the member is retrieving a harvest, or there is a medical emergency.
  - Vehicle travel is allowed on certain designated ATV trails during hunting seasons.** These trails are clearly defined as a red trail on the club maps or by red dots to mark the end of a designated ATV trail. With the exceptions of retrieving a harvest or a medical emergency, travel beyond the end of a designated ATV trail is by foot only.
  - Foot travel for scouting after Labor Day is available between 11:00 AM and 4:00 PM on Sundays only. Members must sign in and out to scout a hunting area. Please ensure there are no hunters in the area you intend to scout.
  - Any member confirmed to be accessing club properties after Labor Day weekend outside the guidelines above or without special permission from the club's leadership, will be assessed a fee of **\$50** for each occurrence.
4. **Record Your Harvest.**
- ALL** harvests must be recorded in the sign in/out book at the tract and on the main harvest board in the map room at the clubhouse as soon as possible, providing all information requested.
  - All sightings of any wildlife (deer, turkey, coyotes, foxes, etc.) must be recorded on an observation card and placed in the collection box in the map room. This is very important for us to maintain our leases, as this is a requirement of the lease terms.**
5. **Stands.**
- Every 1st year member is required to rent a stand for a fee of \$100 (included in membership dues). This is for the first year only and a tract coordinator will work with you for this stand assignment.
  - All 2nd members are required to provide a club approved stand that is at least 4x5 with a chair, roof, walls, and appropriate window wrapping, that will seat an adult and a child (two chairs/seats). We also have a local supplier from which members may purchase club approved stands. These stands are 4x6, and come with a roof, floor, and ladder, but the side walls, window wrap, and chairs must be provided by the member. The 4x6 stands sizes currently are, a ground blind, 5 ft., 7 ft., and 10 ft. Pricing for the 4x6 stands varies by size and pricing will be provided each year upon request. Club stands remain the property of Rack & Spur Hunt Club, LLC.
  - All new stands are required to be at the club house and ready to be installed no later than the first Saturday in May. Installation will be scheduled by the club's leadership.
  - Members are responsible for maintaining their rental stand or club stand making sure they are in good condition, safe, and huntable by September 1<sup>st</sup>.
  - While trimming lanes are a part of our scheduled work days, each member is ultimately responsible for ensuring the shooting lanes at their club stand are trimmed appropriately and ready to hunt by September 1<sup>st</sup>.
  - Rack & Spur Hunt Club, LLC will monitor all club stands. Stand owners who are neglectful in maintaining their stand will be notified of the required corrective action. If that corrective action is not taken by September 1<sup>st</sup>, Rack & Spur Hunt Club, LLC reserves the right to make repairs and charge the member appropriately and/or limit club activities of that member until corrective actions are complete.



- g. Respect the stands. Do not modify someone else's stand (e.g. cutting/removing wrapping). Whatever you take into a stand, take it out with you. If it is determined that a member is leaving trash behind or littering the property, Rack & Spur Hunt Club, LLC reserves the right to limit/eliminate club activities for the member and/or assess that member with a fine of **\$75 per incident**. **Littering our properties can cause us to lose our lease!**
- h. **IPS** (Independent Personal Stands) – Once a member has installed their club stand, and are at least a 2nd year member, they may request to put up an IP stand for a fee of **\$150 (this is an annual fee)**.
  - i. An IP stand is a stand that can only be hunted by the owner or by another member or guest if permission is requested and granted by the owner of the IPS.
  - ii. No permanent stand, lock-on, climber, or other portable stand may be installed within 200 yards of an IPS.
  - iii. IP stand location must be approved by the club president **PRIOR** to installation.
  - iv. IP stands must be installed by June 1st.
- i. Climbers, lock-ons, and portable ladder stands are allowed, but due to the portability, **the tract coordinator must approve the placement of these prior to installation. This is a safety issue!**

#### 6. Workdays.

- a. There are 2 workdays per month starting in February and these are scheduled the 2<sup>nd</sup> and 4<sup>th</sup> Saturday of each month. ***Everyone needs to sign in to get credit for the workday.***
- b. Workdays begin by meeting at 7:15 AM at the clubhouse for assignments. We normally break for lunch around 11:30 AM-12:00 PM. This is followed by the afternoon session which normally runs until about 3:30-4:00. If you only work one of the sessions, you only get credit for ½ a workday.
- c. Everyone is required to make workdays according to the membership package purchased. For late joining members, special projects are available to make up workdays. There is a **\$150** assessment per missed workday.
- d. Everyone is expected to bring his or her own tools.
- e. If you are on the club property during workdays, you are expected to participate in workday activities unless you are a sportsman's member for which no workdays are required for 2025.
- f. Workdays are for club projects, not individual projects such as working on club or IP stands or scouting.

#### 7. Shooting Range.

- a. The shooting range is located on Radio Lane (tract 1).
- b. Members must sign in and out at the clubhouse on Saturdays and at the tract 1 in/out board. Other than Saturday, you can sign in and out at the tract 1 in/out board. ***YOU MUST ENSURE NO ONE IS BEHIND THE RANGE BEFORE YOU USE THE RANGE! This is a safety issue!***
- c. During turkey and deer seasons, the range is available between 12:00 PM and 3:00 PM and therefore there is no hunting or scouting within 300 yards of the range during this time. The range is available anytime outside of turkey or deer season ***provided no one with hunting or scouting behind the range.***
- d. Please police behind yourself when using the range. This includes brass, targets, and trash. If you don't want your brass, there's a bucket for the collection of the brass.



#### 8. Membership Levels & Dues.

- a. Membership for Rack & Spur Hunt Club, LLC is based on a calendar year from January 1<sup>st</sup> to January 1<sup>st</sup> of the next calendar year regardless of when the member joins. All memberships cover the member, spouse, and any children under 18 living with the member.
- b. Each January, a **\$100 deposit** must be submitted to hold a returning member's spot and the membership should be paid in full by March 31st.
- c. Partial payments are allowed, however, **dues must be paid in full before a member is allowed to hunt or scout on any of the club properties.**
- d. The available memberships and fees for 2025 are:
  - i. Basic Membership (1st year member) - **\$1150** if paid by March 1<sup>st</sup> and **\$1225** if paid after March 1<sup>st</sup>
  - ii. Basic Membership (2nd year member) - **\$1050** if paid by March 1<sup>st</sup> and **\$1125** if paid after March 1<sup>st</sup>
  - iii. Sportsmans Membership - **\$1400** paid anytime and **\$1475** if paid after March 1<sup>st</sup>

#### 9. Membership Requirements

- a. Basic members
  - i. Only membership available for first year members.
  - ii. 2nd year members must build or purchase and maintain a club approved stand.
  - iii. 3rd year or older members must maintain their club stand.
  - iv. 6 work days are required and 1 workday must be a fall planting day.
  - v. Must attend 1 of the 2 club meetings (DATE TBD).
- b. Sportsmans members
  - i. Only available to 2nd year or older members.
  - ii. 2nd year members must build or purchase and maintain a club approved stand.
  - iii. 3rd year or older members must maintain their club stand.
  - iv. NO work days are required.
  - v. Must attend 1 of the 2 club meetings (DATE TBD).

#### 10. Membership Dues Refund.

- a. Dues are generally non-refundable
- b. Exceptions:
  - i. Incapacitating illness of the member or member's immediate family.
  - ii. Job transfer.
  - iii. Other exceptions can be granted through the club's president (only in rare circumstances).
- c. If a refund is granted, the maximum refund will be 50% of the dues that have been paid, provided the club's treasury has the funds available.

#### 11. Visitors.

- a. Definition of a Visitor is: 1 person (man, woman or child) not covered under your membership.
- b. You must purchase a Visitor's Package in order to bring visitors.
- c. A Visitor's Package is available for **\$150** per year. With this package you can bring as many visitors as you wish throughout the year, but each visitor can only come for 5 hunts.
- d. Visitors are allowed anytime during turkey season and starting November 1st during deer season.
- e. Visitors who are hunting under a member's Visitors Package can stay overnight in the clubhouse for free.
- f. Each member is allowed 1 guest per hunt. A hunt is defined as a morning hunt **or** an afternoon hunt.
- g. **Visitors must sign a Release of Liability form PRIOR to hunting.** The visitor only needs to sign 1 statement per year. These forms are available in the map room and should be left in the box in the map room and the sponsoring member is responsible for ensuring the form is signed and left in the box.
- h. Both the visitor and the sponsoring member must hunt the same tract of land.
- i. If hunting on Saturday, visitors must be present at the draw and sign in and out like all other members.
- j. ***Visitor's packages must be purchased no later than opening day of the season you wish to bring visitors.***



12. **Non-rejoining members.**

- a. Any member not rejoining Rack & Spur Hunt Club, LLC should notify anyone on the club's leadership prior to February 15<sup>th</sup>.
- b. Those not rejoining should remove any personal stands (**not your club stand**) or other personal property from the club. Removal of this property is only allowed after the youth hunt day in January through February 15<sup>th</sup>.
- c. Any personal property not removed by February 15<sup>th</sup> will be considered abandoned and become the property of Rack & Spur Hunt Club, LLC. At that point, Rack & Spur Hunt Club, LLC can and will dispose of, move, or use this property as it sees fit.

13. **Family members wishing to hunt alone.**

- a. Must be 18 years of age or older.
- b. Must have a valid SC hunting license.
- c. Must have attended a SCDNR approved hunter safety course.
- d. At no time is a person under the age of 18 allowed to hunt on the club's properties unless a parent or guardian is present and is ***in the same stand*** with that individual. The parent or guardian and the individual must have a dependable form of communication (e.g. cell phone).

14. **Food Plots.**

- a. Rack & Spur Hunt Club, LLC makes every attempt to attract and keep wildlife on our properties.
- b. We have designated food plots on each tract that we plant. Some are planted in the spring and the fall.

15. **Clubhouse**

- a. You must sign in and out of the sign in/out book for overnight stays.
- b. Your money for the stay should be put in an envelope and placed in the ammo box on the wall. You should write your name and what is being paid for on the outside of the envelope.
- c. Overnight stays are **\$10** per night. This is a per person fee.
- d. An unlimited stay package is available for **\$150**. This covers your immediate family.
- e. We ***DO NOT*** have a maid service, so ***CLEANUP YOUR MESS***.
- f. Empty the refrigerator of any items you brought with you when you leave the clubhouse.
- g. If you find anything that is expired/spoiled, please throw it out too.
- h. If the outside trash cans are full, take the bag with you and drop it off at one of the trash collection sites around Saluda.

16. **Camping/Campers.**

- a. Whether camping or staying in your camper, you must sign in and out of the sign in/out book in the clubhouse.
- b. Camping and Camper parking is available at the clubhouse.
- c. Camper parking is **\$350** a year regardless of how long it is parked at the clubhouse.
- d. Camping Fees: (e.g. tents on club house property)
  - i. Overnight stay fee is **\$10**. This is a per person fee.
  - ii. Unlimited camping fee is **\$150** a year. This covers the immediate family.
- e. Your money for the stay should be put in an envelope and placed in the ammo box on the wall. You should write your name and what is being paid for on the outside of the envelope.
- f. ***No electric heaters are allowed in the clubhouse.***
- g. When leaving your camper and not coming back for a day or more, please make sure to empty your refrigerator and unplug your camper. ***If you leave your camper plugged in and it is determined you will not be back for a day or more, your camper will be unplugged.***



**17. Annual Club Meeting.**

- a. We have 2 club meetings per year and every member is required to attend at least 1 of these meetings. The first meeting is normally held in the spring and the second meeting is held right before deer season. Club members will be notified of the dates when they have been determined.
- b. All members are responsible for the content of this meeting regardless of attendance.

**Rack & Spur Hunt Club, LLC Operating Policy:** Rack & Spur Hunt Club, LLC operates within the framework of its Constitution & By-laws managed through a set of Rules, Regulations, Policies, & Privileges set forth by the club's leadership. The club leadership has the right to enforce change or adjust the Rules, Regulations, Policies, & Privileges at any time at their discretion; pending the approval from the club's Executive Board. Any/all changes, additions, or adjustments will be immediately posted on the club website and in the main clubhouse. Penalties for violating any of these Rules, Regulations, Policies, & Privileges can immediately be enforced through verbal warnings, fines, suspension or termination to part or all of a club members privileges for an indefinite period of time (pending an Executive Board review). Once again **Safety** is our #1 priority.
